Astragalus Complex is a unique combination of Astragalus root, Eleuthero root and Echinacea root. Extracts of herbs may be ‘standardized’ – this means they must contain a certain amount of important constituents. Top quality Eleuthero extracts are standardized for syringaresinol diglucosides content (as eleutheroside E).*

How Astragalus Complex Keeps You Healthy Enhances immune system function & promotes healthy response to environmental stresses

Astragalus has been used traditionally to support immune system function.^{1*}

The root of *Echinacea purpurea* was used by the Native Americans to enhance immune system function.² A placebo-controlled trial found that *Echinacea purpurea* root assists the body’s immune response by helping with normal phagocytosis.³ This is a process involving certain white blood cells that engulf and digest foreign particles or cells that might challenge the body. A practical effect is that top quality Echinacea root helps the immune response following stress or sudden changes in weather.*

A small, uncontrolled clinical study confirmed that Astragalus enhanced immune system function in healthy volunteers.⁴ Many controlled clinical trials have shown that Eleuthero extract enhances immune system function in healthy participants.⁵ In an uncontrolled trial, Eleuthero helped restore normal immune function by supporting the body’s production of white blood cells.^{6*}

In a randomized controlled clinical trial, Eleuthero also reduced cardiovascular responses to stress in healthy volunteers.^{7*}

Assists the body’s natural repair processes and maintains general well-being

Astragalus has been used traditionally to support stamina and endurance.¹ It is one of the main tonics used traditionally to enhance vitality in the Chinese herbal system.⁸ The tonic action of Astragalus is used by natural clinicians to assist the body in its natural repair process.⁸ (A tonic is popularly thought of as something that makes you feel better, stronger or healthier. Chinese tonics of the type to which Astragalus belongs, replenish the body’s vital reserves over the long term, support the constitution and aid the body’s natural regeneration and repair functions.⁹)*


In a randomized controlled trial, Eleuthero extract improved the quality of life in elderly patients.¹⁰ Eleuthero is also recommended traditionally for assisting the body in its natural repair process.^{5*}

Why use top quality Echinacea root?

The root of *Echinacea purpurea* was chewed by the Native Americans for therapeutic use.² In the late 19th Century, natural clinicians in the United States noted that “when chewed the root, if of good quality, imparts a persistent tingling sensation”.¹¹ We now know that this tingling sensation is caused by the presence of the plant constituents called alkylamides (pronounced al-kyl-a-mydes). Compared to the aerial parts (flower, leaves, stem), the roots contain the highest amounts of alkylamides.^{12,13*}

Research conducted by international groups strongly suggests that the alkylamides:

- are very important for the immune system effects of Echinacea¹⁴⁻¹⁶
- are absorbed into the bloodstream^{17,18*}

- Top quality organically grown plants are used in the manufacture of the Echinacea component of this tablet
